- The maximum Federal Direct Student Loan funding that can be offered to a student for an academic year is \$20,500. **However, a student's personal eligibility may not allow for loan certification to this amount.**
- Students must reapply each academic year for financial aid, including student loans. The academic year runs Fall through Summer.
- **You must complete the Free Application for Federal Student Aid (FAFSA)** in addition to the Eden Theological Seminary Financial Aid Application (this form). Additional information or forms may be required to complete your application after these documents have been submitted. The FAFSA is available online at www.fafsa.gov.
- **Any changes in your projected or actual enrollment will change your eligibility.**
- You should complete all application materials as soon as possible. Applications completed less than one month prior to the end of your enrollment period or academic year (whichever is earlier) may not be processed in time to secure funding.
- When your file is complete and your eligibility is determined, you will be sent an aid offer that shows the amounts and conditions of the funds scheduled for you to receive.
- Federal financial aid is only awarded for classes required for your degree program.

CERTIFICATION
