Students at Eden Seminary are eligible to apply for federal, direct unsubsidized loans. Students may borrow up to \$20,500 per academic year, depending on their Cost of Attendance. Disclaimer Regarding Tuition and Fee Rates

Transfer Credit Policies

In routine matters (when fewer than 15 credits are being transferred from an ATS-accredited graduate school, the courses are less than seven years old and the grades are B- or higher) the Academic Dean will make decisions regarding the acceptance of transfer of credit. Credit for previous course work will be given only when the work is presented as part of the original admissions process and documentation. An official transcript showing the grades received must be on file in the Office of the Registrar before transfer of credits will be considered. An assessment of the course work will be made at the student's request. A transfer evaluation will be completed and the results will be communicated to the student. These results are an estimation of the course work (and its Eden course equivalents) that Eden anticipates will transfer.

Requirements for Graduation and Timeline

Master of Divinity (MDIV)

students accepted into the MDIV program in the Fall 2025 term can reasonably be expected to complete their requirements for graduation and graduate in the Spring 2028 term.

Master of Theological Studies (MTS)

students accepted into the MTS program in the Fall 2025 term can reasonably be expected to complete their requirements for graduation and graduate in the Spring 2027 term.

Master of Professional Studies (MAPS)

students accepted into the MAPS program in the Fall 2025 term can reasonably be expected to complete their requirements for graduation and graduate in the Spring 2027 term.

Doctor of Ministry (DMIN)

students accepted into the DMIN program in the Fall 2025 term can reasonably be expected to complete their requirements for graduation and graduate in the Spring 2028 term.
